#### CHAIRMAN'S MESSAGE

#### **Pullet Growers of Canada in action**

It is with pleasure that I present the Pullet Growers of Canada's (PGC) thirteenth annual report. Here, you will find information on the activities conducted in 2019 and on the priorities for the year to come. The PGC team has worked hard in the past year to initiate the activities required to achieve the objectives of the new 2019-2023 Business Plan. As a first step, the PGC have met with all the provincial egg and pullet boards to make a presentation about the organization. Thanks to all the boards for your interest and for taking the time to ask relevant questions.

The PGC Board of Directors held its annual business planning cycle in September in order to establish the priorities for the coming year. Many strategic initiatives will be accomplished in 2019-2020 such as creating the PGC website which we want to be a useful tool for pullet growers.

I am taking this opportunity to thank the staff at the *Union des producteurs agricoles* for providing professional human resources to assure the administration of our organization. I would also like to salute the teamwork in which our directors have been engaged, as well as the efforts that they have done for the advancement of our sector and by communicating the issues and challenges facing growers in their respective provinces.

After 13 years as a firm defender of the interests of pullet growers, I decided to retire from my position although I strongly believe that PGC's purpose continues to have relevance in the table egg supply chain, and in fact can be a critical success factor in ensuring that pullet grower concerns are addressed in a proactive and positive way.

#### MINUTES OF THE THIRTEENTH ANNUAL GENERAL MEETING

MINUTES OF THE THIRTEENTH ANNUAL GENERAL MEETING
OF THE PULLET GROWERS OF CANADA
THE WESTIN OTTAWA, OAK ROOM
MARCH 19, 2019

#### 1. WELCOME AND OPENING REMARKS

Mr. Andrew DeWeerd, Chairman of the Pullet Growers of Canada (PGC) welcomed the 24 participants at the thirteenth annual general meeting (AGM), including growers and guests. The Chairman mentioned that it was a fruitful and busy year, but a difficult one also. Indeed, Ms. Lucie Gionet, former executive director of the PGC, lost a courageous battle against cancer and passed away on March 15, 2019. After sharing some good memories of Ms. Gionet, the Chairman asked the attendees to hold a minute of silence in her honour.

**ON MOTION DULY MOVED** by Mr. Scott Graham and seconded by Mr. Dan Veldman, it was unanimously resolved to approve the agenda of the thirteenth PGC AGM.

#### 2. INTRODUCTION OF THE BOARD OF DIRECTORS AND STAFF

The Chairman introduced the Board of Directors who represented the PGC's seven member provinces over the last year, namely Mr. Daniel Wollman (Saskatchewan), Mr. Harold Froese (Manitoba), Mr. Dan Veldman (Ontario), Ms. Marie-Josée Forest (Quebec), Mr. François Jacques (New Brunswick), Mr. Jeffrey Clarke (Nova Scotia) and Ms. Mary Oliver (Newfoundland-Labrador).

The Chairman introduced the staff who took care of the administration of the PGC over the last year, namely Ms. Jennifer Crawford, acting executive director, and Djazia Abdoun, administrative assistant. He mentioned that, unfortunately, Ms. Crawford will soon resign from her position at the PGC because she was offered a full-time position as the executive director of the strawberry and raspberry growers of Quebec. The Chairman thanked her for all the good work that she has accomplished during her mandate with the PGC. The Chairman introduced Ms. Katia Colton-Gagnon which will become the executive director of the PGC.

The Chairman asked the attendees to introduce themselves.

#### 3. MINUTES OF THE TWELFTH ANNUAL GENERAL MEETING

Ms. Jennifer Crawford read the minutes of the twelfth AGM. No corrections to the minutes were asked.

**ON MOTION DULY MOVED** by Mr. Daniel Wollman and seconded by Mr. Harold Froese, it was unanimously resolved to approve the minutes of the Twelfth Annual General Meeting held on March 20, 2018, at The Westin Ottawa.



#### 4. 2018 REPORT OF ACTIVITIES BY THE CHAIRMAN

#### 4.1 Representations

The PGC directors continued to represent the interest of pullet growers on national committees, namely the Canadian Egg Industry Reciprocal Alliance (CEIRA) Board of Directors, the Egg Farmers of Canada (EFC) Hazard Analysis and Critical Control Points (HACCP) Review Team, the EFC Production Management Committee and the EFC Animal Care Program Redevelopment Project Team.

The PGC also met with staff of Agriculture and Agri-Food Canada on January 16, 2018, to discuss about the national marketing agency request. Regarding the national marketing agency, no further step was taken to resubmit a request as results of the member survey done for the development of the new PGC Business Plan showed decreasing interest in the pursuit of this objective.

#### 4.2 Operations

The Chairman mentioned that the Board of Directors held 7 meetings by teleconference and 3 in-person meetings (on March 20 in Ottawa, on September 18 & 19 in Ottawa [fall meeting] and on November 19 in Toronto [work meeting for updating the Care of Pullets Guidebook]).

#### **4.2.1** Finance and Audit Committee

The 2018 financial statements have been approved in the morning by the Board of Directors. Incomes are quite similar to 2017. However, expenses were significantly higher in 2018 mainly because more professional services were engaged to conduct PGC's work and a firm was contracted to craft the new PGC Business Plan. Also, the directors' travel expenses were now at the charge of PGC (in the past, they were paid by the provincial organizations).

**ON MOTION DULY MOVED** by Mr. Harold Froese and seconded by Ms. Marie-Josée Forest, it was unanimously resolved to approve the 2018 financial report.

**ON MOTION DULY MOVED** by Mr. Harold Froese and seconded by Mr. Jeffrey Clarke, it was unanimously resolved to appoint Raymond Chabot Grant Thornton as the public accountant for 2019.

As for the 2019 budget, a greater amount has been allocated for professional services (mainly for staff) to accomplish the PGC's new Business Plan.

**ON MOTION DULY MOVED** by Mr. Harold Froese and seconded by Mr. Daniel Wollman, it was unanimously resolved to approve the 2019 budget.

#### 4.2.2 Communications Committee

No meeting took place in the past year. Two newsletters (winter and summer) were sent to provincial and national organizations.

#### **4.2.3 Cost of Growing Committee**

No meeting took place in the past year. The firm MNP was contracted to conduct the cost of growing survey for pullets raised in aviary systems.



#### **4.2.4 Production Management Committee**

Regarding the Animal Care Policy for pullets, a PGC representative has been actively participating in the EFC Animal Care Program Redevelopment Project Team to ensure coherent and adequate completion of all elements relating to pullets.

The PGC started to update the Care of Pullets Guidebook to make it compatible with the Code of Practice for the Care and Handling of Pullets and Laying Hens. The PGC intend to release the updated version in 2019.

#### 2019-2023 BUSINESS PLAN

The year 2018 was the last year of the 2015-2018 PGC's master plan. A new Business Plan spanning from 2019 to 2023 was developed during the second part of the year to renew PGC's short and long-term objectives. The mission, the immediate priorities and the work plan objectives are presented.

#### 6. COST OF PRODUCTION STUDY FOR PULLETS IN AVIARY SYSTEMS

The PGC contracted the firm MNP to conduct an aviary cost of growing survey to follow up on the conventional and floor production studies. The study is based on 2017 producer data located in the provinces of Ontario, Quebec and Manitoba. The results of the study still require some analysis to be done by the Board of Directors and will be rendered available later in 2019. The study is meant to provide insight into the variance in costs for this production system compared to conventional and floor production systems.

#### 7. PRODUCTION MANAGEMENT UPDATE (MR. JEFF CLARKE)

Mr. Jeffrey Clarke provides an update regarding the work conducted by the EFC Production Management Committee to implement the Code of Practice for the Care and Handling of Pullets and Laying Hens.

#### 8. APPOINTMENT OF OFFICERS (BY PROVINCIAL REPRESENTATIVES)

The election of the PGC officers for the next year took place during the meeting of the Board of Directors held earlier today.

#### REPORT OF ACTIVITIES

#### **Board of Directors Meetings**

In 2019, PGC's Board of Directors (BOD) held five teleconferences to monitor activities and guide the work being done. The BOD also met in person prior to the 2019 AGM in Ottawa, for a work meeting in Toronto (June 28) and for the Annual Fall Meeting in Halifax (September 11-12).

The staff that took care of the administration of the PGC over the last year includes Ms. Jennifer Crawford, acting executive director, and Ms. Djazia Abdoun, administrative assistant. As of April 1<sup>st</sup>, Ms. Katia Colton-Gagnon became the executive director when Ms. Crawford resigned. Ms. Colton-Gagnon and Ms. Abdoun are both employed by the Agricultural Research and Policy Branch of the *Union des producteurs agricoles*.

#### Representations

#### Egg Farmers of Canada (EFC)

In 2019, the PGC Chairman and directors attended various meetings to discuss the issues facing our sector with the EFC directors, particularly regarding the implementation of the pullet portion of the *Code of Practice for the Care and Handling of Pullets and Laying Hens* with the EFC Animal Care Program Redevelopment Project Team. Our two organizations intend to develop audit methods that reflect the new requirements of this code. PGC representatives also sit on the EFC's Production Management and HACCP committees.

#### Canadian Egg Industry Reciprocal Alliance (CEIRA) Board of Directors

In 2019, the PGC vice-chairman attended 2 in-person meetings and 4 meetings by teleconference to provide the perspectives of pullet growers.

#### **Main Projects**

#### **Presentation to Provinces**

PGC provided a 30-minute in-person presentation to all the provincial egg and pullet boards (except for British Columbia and Quebec which will be visited in early 2020) to present our 2019-2023 Business Plan, our mission and values, our history, our governance structure, our committees and staff, what we do, PGC's priorities for 2019 and our budget. The intent of this national tour is to explain PGC's need for support from all the provincial egg and pullet boards in order to have programs efficiently delivered to pullet growers and to be recognized as a national organization engaged in the oversight of all activities related to pullet production. PGC needs the support of all the provincial egg and pullet boards to move forward as well as formal agreements to ensure communication with pullet growers across Canada.

#### Survey on the Aviary Pullet Cost of Growing (COG)

PGC hired the consulting firm MNP  $_{\rm LLP}$  to conduct a cost of growing (COG) study for the aviary pullet production system following completion of earlier surveys during 2009 and 2015-2016 for cage and floor production systems respectively. These earlier COG studies were based on 2007 and 2014 producer data. This aviary COG study is based on 2017 data from six growers located in the provinces of Manitoba, Ontario and Quebec.

The results of the aviary COG study were presented in the PGC's newsletter and show a differential supplemental cost of 1.40\$ per pullet when compared to the COG study for a cage system. Mainly because of the very small sample size that limits representativeness and reliability, the PGC Board of Directors decided not to publish the detailed results of the study.



The sample size was limited because many growers contacted during the screening period had to be excluded due to their recent start date in an aviary operation. Hence, the number of operations with long stable operating histories is currently limited which might lead to higher costs as they are still in their start-up phase (most started in 2015-2016). To remedy this concern, additional sampling will be required to increase confidence in the resulting COG. Some growers also had to be excluded because they have multiple poultry enterprises on their farm and were unable to segregate costs for the aviary operation.

In the future, when more growers will operate aviary systems, it will be possible to establish a more reliable COG for this type of production. Nonetheless, starting or converting to an aviary system requires a higher capital cost per pullet as compared to more traditional production systems.

#### Care of Pullets Guidebook

The pullet care guide, developed by PGC and first published in 2016, provides Canadian pullet growers with the information they need to handle the birds under their care with respect and compassion. Over the last year, PGC has assessed what modifications and specifications will have to be made to the Guidebook in order to make it compatible with the *Code of Practice for the Care and Handling of Pullets and Laying Hens*. An updated and bilingual version will be available in 2020.

#### 2019–2023 BUSINESS PLAN FOLLOW-UP

Planning within PGC is a group effort by the Board of Directors, the Executive Committee, and staff. The year 2019 was the first year of the five-year period PGC's Business Plan.

PGC identified the following priorities for 2019:

- To offer the PGC presentation to all the provincial egg and pullet boards;
- To participate actively in the meetings of the EFC Animal Care Program Redevelopment Project Team;
- To investigate for funding sources to implement the Animal Care Assessment Program for pullets;
- To update and finalize the Care of Pullets Guidebook with the new requirements of the Code of Practice;
- To hold a meeting between the PGC and EFC executive committees;
- To obtain official participation of a representative appointed by PGC on the EFC Production and Management Committee;
- To create the PGC website.

These priorities are included in the Key Result Areas defined as where PGC must be successful in order to be true to its mission and vision, as follows:

- 1. Operations
- 2. Communications
- 3. Governance
- 4. Management and Administration

#### **EVALUATION OF KEY RESULT AREAS**

#### **KEY RESULT AREA 1: OPERATIONS**

#### **OBJECTIVE**

To be recognized as a national organization engaged in the oversight of all activities related to pullet production.

#### **GOALS**

To collaborate with provincial players leading to the recognition of the PGC as the national representative of pullet growers.

- Accountability: Chair (Executive Committee, provincial organizations, Executive Director)
- Target date: April 2019
- Performance indicator: Three-year funding agreement defined and agreed to by member provinces.

**PROGRESS:** In March, a request for a three-year funding agreement was sent to all the provincial organizations. As a result, six provincial organizations have agreed to contribute to the PGC on a yearly basis. From September to December, PGC offered a presentation to all the provincial organizations (except for British Columbia and Quebec which will be visited in early 2020).



To lead the development and implementation of programs related to the Code of Practice and Animal Care Policy for pullets.

- Accountability: Chair of Production Management Committee
- Target date: 2021
- Performance indicator: Being delegated formal responsibility for code related programs; development of the pullet program and assessment measures; preparation and administration of the producer level guide book and training tools.

**PROGRESS:** One PGC representative actively participates to the meetings of the EFC Animal Care Program Redevelopment Project Team for the development of the pullet program and assessment measures. Following a letter sent to EFC in 2019, the PGC and EFC executive committees will meet in early 2020 to discuss about official participation of a representative appointed by PGC on the EFC Production Management Committee. PGC updated the Care of Pullets Guidebook according to the new requirements and some recommended practices of the 2017 edition of the Code of Practice and will publish this updated version in 2020.

To participate to the COP for pullet production in Canada both for the next COP as well as the Re-Base to be conducted between formal COP.

- Accountability: Chair of COP Committee (Executive Director, FPCC)
- Target date: Summer of 2019 or whenever the EFC COP Committee is formed to initiate the review process for the next re-base and/or COP update.
- Performance indicator: An agreement with EFC that the PGC will be involved in the development of the questions used in the next COP as they relate to pullet production.

**PROGRESS:** Following a letter sent to EFC in 2019, the PGC and EFC executive committees will meet in early 2020 to discuss about official participation of a representative appointed by PGC on the EFC Production Management Committee.

To ensure that a representative from PGC is a permanent member of the EFC Production Management Committee and Animal Care Program Redevelopment Project Team.

- Accountability: Chair (Executive Director, Board of Directors)
- Target date: 2023
- Performance indicator: Permanent membership on the committees of a PGC representative.

**PROGRESS:** Following a letter sent to EFC in 2019, the PGC and EFC executive committees will meet in early 2020 to discuss about official participation of a representative appointed by PGC on the EFC Production Management Committee.



#### **KEY RESULT AREA 2: COMMUNICATIONS AND ENGAGEMENT**

#### **OBJECTIVE**

To ensure effective communication between PGC and growers/stakeholders using all available means and channels.

#### **GOALS**

To strengthen the partnership between PGC and EFC in order to manage issues of common concern and to pool resources:

- Accountability: Chair (Executive Committee, Board of Directors)
- Target date: Ongoing
- Performance indicator: Structured and regular meetings (1 X a year) of PGC with EFC Chair and Executive.

**PROGRESS:** Meetings and discussions with EFC are held on an ongoing basis. A meeting between the executive committees of PGC and EFC is planned at the beginning of 2020.

To sustain relationships with pertinent federal and provincial government agencies/departments aimed at providing information on activities of the PGC.

- Accountability: Chair (Executive Committee, Board of Directors, Executive Director)
- Target date: Ongoing and as required
- Performance indicator: Meetings held (Farm Products Council of Canada, Agriculture and Agri-Food Canada, Canadian Food Inspection Agency); results tracked

**PROGRESS:** No meeting was held in 2019.

To establish the means to inform PGC stakeholders continuously.

- Accountability: Executive director (Chair, Communications Committee)
- Target date: Ongoing
- Performance indicator: Quarterly updates provided to provincial agencies, Board of Directors, and pullet growers, technical support for growers

**PROGRESS:** Directors reported on the activities of PGC to their provincial board. Two newsletters (February and December) were sent to all the provincial organizations and PGC's industrial partners.



To continue providing updates at provincial meetings of pullet growers and stakeholders and annual general meetings.

- Responsibility: Chair (Communications Committee, Executive Committee, Board of Directors, Executive Director)
- Target date: Annually (by February)
- Performance indicator: Common message about the roles and responsibilities of the PGC would be delivered to all stakeholders.

**PROGRESS:** Directors share news about changes in pullet production in their respective province at regular meetings supported by presentations elaborated by the Executive Director.

To develop the PGC website.

- Accountability: Executive Director (Communications Committee)
- Target date: 2020
- Performance indicator: Launch of a bilingual website.

PROGRESS: The firm Créatures Stratégie Image inc. has been contracted to craft the PGC website.

To attend national/international conferences and meetings pertinent to the issues of pullet growers in Canada.

- Accountability: Chair (Executive Committee, Board of Directors, Executive Director)
- Target date: Ongoing and as required
- Performance indicator: Formalized decision process at the Board level in order to determine attendance and funding. Formalized reporting process so that the key points from meetings are distributed to the Board and pullet growers.

**PROGRESS:** Several conferences and meetings were attended by the directors, e.g. Midwest Poultry Federation Convention, 2019 Canadian Egg Farmers Northwest Territories Conference, *Le Rendez-vous avicole*, semi-annual meeting of the Egg Farmers of Quebec, etc.

#### **KEY RESULT AREA 3: GOVERNANCE**

#### **OBJECTIVE**

To establish a formalized governance structure that ensures PGC can act as the independent and autonomous national organization representing Canadian pullet growers.

#### **GOALS**

To perform an annual review of PGC By-Laws to reflect the changes brought about by emerging issues:

- Accountability: Treasurer (Board of Directors, Executive Director)
- Target date: Yearly as ratified at the AGM
- Performance indicator: By-Law changes passed by the Board and AGM.

PROGRESS: No progress.



To engage non-member provinces to determine how best to ensure representation of pullet growers in those provinces so that their input is represented in all aspects of pullet production.

- Accountability: Chair (Board of Directors, Executive Director)
- Target date: 2020
- Performance indicator: All pullet producing provinces are active PGC members.

**PROGRESS:** A letter to request funding and to present the new Business Plan was sent to all non-member provinces. A presentation will be provided to all non-member provinces by early 2020.

#### **KEY RESULT AREA 4: MANAGEMENT AND ADMINISTRATION**

#### **OBJECTIVE**

To deliver programs efficiently to pullet growers and members by having relevant management processes in place based on the resources available and the work to be done.

To improve the management and administrative processes of the PGC:

- Accountability: Executive Director (Executive Committee)
- Target date: 2020
- Performance indicator: Improvements to management and administrative processes are in place, e.g. file management (online database and archives as a specific example).

**PROGRESS:** A new service agreement for the administration of PGC has been signed with the Agricultural Research and Policy Branch of the *Union des producteurs agricoles*. Management and administration of PGC are being accomplished in Longueuil, Quebec.

To continue improving the PGC's bilingual capacity.

- Accountability: Executive Director (Executive Committee)
- Target date: Ongoing
- Performance indicator: Bilingual policy developed and implemented.

**PROGRESS:** All documents are currently published in both official languages.

To implement the annual Staff Evaluation Process.

- Accountability: Chair (Executive Committee)
- Target date: Annually
- Performance indicator: Ongoing cyclical staff evaluation underway.

**PROGRESS:** The staff evaluation was conducted during the fall meeting in September 2019.




To continually improve PGC's financial management processes and funding opportunities and grants.
